CATEGORIES:

Oil, Acrylic, and Pastel

Watercolor and Tempera

Drawing – pen & ink, charcoal, graphite and colored pencil

Photography

Other/Dimensional - Ceramic, Stained Glass, CGI, fabric, sculpture, wood carving, mixed media etc.

AWARDS: Cash awards will be given in each of the categories

First Place \$100

Second Place \$ 75

Third Place \$ 50

Best of Show \$200 (one prize for the entire show)

There will be an Honorable Mention Ribbon given in each category as well

Purchase Award up to \$300 by the Paulding Fine Arts Association

ENTRY RULES:

- Entrants must be 18 years of age or older.
- All work must be the exhibiting artists' *original work* and not a reproduction of another artist's work, including paintings from photographs in magazines, calendars, etc. Work must not have been created while under classroom/instructor supervision.
- All work must have been completed within the past 3 years and should NOT have been exhibited in previous PFAA Competition Exhibits.
- **All 2-D work MUST be framed and wired, ready for hanging.**
Gallery wrapped canvases need not be framed, but sides must be painted.
- The Paulding Fine Arts Association has the right to reject any work due to subject matter
- Security will be provided, however, The Paulding Fine Arts Association, nor the City of Dallas, nor Paulding County, will be held responsible for lost, stolen or damaged items.
- **A 25% commission/fee** will be charged for any piece of art sold during the show. Buyers will be able to take possession of the work at the end of the exhibit.
- Art works must remain on display in the Courtroom Gallery through Friday, May 31, no exceptions. Artists removing any work prematurely will not be permitted to enter the 2020 show.
- Artists give permission to use an image of their artwork for advertising on Facebook, etc.

ENTRY FEES:

PFAA Members \$25 for the first work and **\$5** for each additional work.

Non-Members \$30 for the first work and **\$5** for each additional work.

Limit of three works. Artists must be a member by March 1, 2018 to receive a member discount.

Checks should be made payable to: **Paulding Fine Arts Association or to PFAA.**

JUDGE(S): Independent, professional judges will be selected to judge the competition.
