PICK UP ARTWORK NOT JURIED INTO THE SHOW

If your artwork is not chosen by the judge for this exhibit you will be notified, the unaccepted work should be picked up by **Saturday, September 21st**

All Artwork chosen for the exhibit and competition must be available for display through Saturday, November 2, 2019 and can be picked up at the close of the exhibit beginning Thursday, November 7, 2019. Please make sure to pick up your work no later than Saturday, November 30th. Artwork must not be removed/picked up until AFTER November 2nd.

5 ART CATEGORIES

- Oil – Acrylic – Pastel Paintings
- Watercolor – Tempera – Gouache
- Drawing: includes Graphite – Colored Pencil – Pen & Ink – Charcoal – Pastel Drawings
- Photography
- Other Art Forms includes, but not limited to Stained Glass – Fabric – Sculpture – Ceramic – Mixed Media (**containing 3 or more media types-all media must be listed**) – Metal works, etc.

Paulding Fine Arts Association reserves the right to refuse any works deemed unsuitable for this exhibition

REQUIREMENTS

All 2-dimensional pieces are to be framed and ready for hanging with wire. **PLEASE do not submit easel back frames or work that has not been wired.** Please note that some sawtooth hangers will not fit our hanging system. **WIRED frames are the best method of preparing your work for showing.** Also note that wires should be fairly taught to display your work in the best possible way. Gallery wrap canvases are acceptable if the sides are painted (staples MUST NOT be showing). For the best presentation of your work it is suggested that watercolor/tempera/gouache/drawings and photography should be matted and must be framed (photography printed on canvas is an exception). Entries may not exceed 60" in width or height.

ELIGIBILITY

Artists must be 18 years of age or older. All work MUST be the exhibiting artist's ORIGINAL work and not a reproduction of another artist's work which includes paintings from published photographs (magazines, calendars, etc.). Work must not have been created while under classroom/instructor supervision. Work should have been completed within the last 3 years and should NOT have been exhibited previously in **ANY** PFAA Competition Exhibit.

ENTRY FEE

Members \$25 for up to 3 pieces (*membership must have been established by August 31, 2019*)

Non-Members \$30 for up to 3 pieces

SALES OF ARTWORK

Sales are encouraged, but please be advised that PFAA will collect a 25% commission on all exhibit sales, please price your work accordingly.

LIABILITY

Insurance is the responsibility of the individual artist. Entrant's signature on the entry form indicates agreement with these conditions.
