Remember any work in the exhibit must be available for display through Friday, November 2, 2018.

Artwork must not be removed/picked up until Saturday, November 3, 2018.

All artwork **MUST** be picked up by December 8, 2018 or it will be disposed.

**5 Categories:**

Watercolor and Tempera

Oil and Acrylic and Oil Pastel

Drawing: Graphite, Colored Pencil, Pen, Chalk Pastel, and Ink

Photography

Dimensional: Stained Glass, Fabric, Sculpture, Ceramic, Mixed Media paintings that contain more than 3 types of media (all media must be listed), etc.

*The Paulding Fine Arts Association reserves the right to refuse any works not deemed suitable for this show.*

**Requirements:**

All pieces are to be framed and ready for hanging with wires. No saw tooth hangers are permitted. Gallery wrap canvases are acceptable if the sides are painted. For best presentation, it is suggested that watercolor/tempera, pastel work, drawings and photography should be matted.

Entries may be no larger than 60" wide.

**Eligibility:**

Artists must be 18 years of age or older. All work must be the exhibiting artists' *original work* and not a reproduction of another artist's work, including paintings from photographs in magazines, calendars, etc. Work must not have been created while under classroom/instructor supervision. All work must have been completed within the past 3 years and should NOT have been exhibited in previous PFAA Competition Exhibits.

**Entry Fees:**

Members \$25, Non-Members \$30

Maximum of 3 submissions per artist

(For a reduced rate, one must be a member prior to entry date.)

**Sales of Artwork:**

Sales will be encouraged, but please be aware a 25% commission of all sales will be donated to the Paulding Fine Arts Association.

**Liability:**

Insurance is the responsibility of the individual artist.
