ENTRY RULES:

1. Any Paulding County resident from age 3 through 18 years of age may submit **ONE** piece of art work.
 2. Each student must submit an *Entry Fee* of **\$2.00**.
 3. The artwork must be the **student's original work** and may be in 2 or 3 dimensional media.
 4. No computer generated art will be accepted in this show.
 5. All 2 dimensional art work must be **matted, mounted or framed** and **have a hanger on the back**.
 6. Entry must be properly wired to hold the weight of the artwork, and ready for hanging.
 7. A professional judge from out of Paulding County will be selected for the judging.
 8. The art entry, form, label and entry fee must be delivered on the delivery dates above and filled out correctly.
 9. Winning students will have group photos taken for the PFAA website and newspaper after the award ceremony.
